



## **BEDOUIN FREEFORM TENTS – GUIDELINES FOR SITE INSPECTIONS AND QUOTATIONS**

The following terms and conditions apply to site inspections, quotations and work conducted by Bedouin Freeform Tents. Please contact an Event Consultant on 1300 55 15 80 if you have any queries regarding these terms.

**ACCESS TO SITE AND PRESENCE AT THE INSPECTION** - Although it is not necessary for you to be onsite during a site inspection we believe that your presence will assist in ensuring we are able to more clearly understand your requirements and best achieve the outcome you desire. We do understand however that your time is valuable and so can do site inspections without a representative present. However under these circumstances the customer waives the right to alteration to the design and format of the resultant installation. Where you are unable to attend a site inspection we request that you ensure an adequate written explanation is provided to our Event consultant for access to the site, a clear guideline to the location for the event and any directions on the installation requirements.

**ACCEPTANCE** – A quotation can only be deemed to have been accepted by a client upon receipt of the following:

- a signed copy of Bedouin Freeform Tents "Rental Terms and Conditions" documentation
- payment of 50% deposit of the quotation total.

Bedouin Freeform Tents reserve the right to charge accordingly for late acceptance of quotations and proceeding with the quotation is based solely on our ability to fulfill, based on stock and resource available.

**WEATHER LIMITATIONS** – All hire items are designed for installation and have limitations and restrictions under certain conditions. Where possible Bedouin Freeform tents will quote with these contingencies in mind. In the event of high winds or severe weather conditions we reserve the right to decide not to proceed with the installation in conjunction with safe working practices and occupational health and safety regulations. Moreover our decisions are made for the care and safety of the client and the clients guests. Under these circumstances the client have no claim whatsoever against Bedouin Freeform Tents for such a cancellation.

### **Clients Site Responsibilities**

**PREPARATION** – It is the customers responsibility to ensure that access to the site is clear and that the site is free of any obstructions which may include, but are not limited to, vehicles blocking access, pots, garden furniture, play equipment, clothes lines, pot-plants, and pet droppings. Tree branches must be removed or tied back prior to our arrival. It is a requirement that any pets, friendly or otherwise, be suitably contained or temporarily removed from the site for the safety of the pets and Bedouin freeform Tents staff. We take no responsibility for pets that might stray during the course of an installation or removal.

**VARIATIONS TO THE SITE** – You must inform our Bedouin Freeform Tents of any alterations to the event site following a site inspection as additional charges may apply if alternative installation methods are required.
